The author is focusing on very current and important topic in environmental problems – clothing and its impacts on environment. The thesis is logically structured and underlaid by facts. I would point out one thing - in the chapter 4. Environmental Scanning some introduction to the method in the beginning of the paragraph would be welcomed – for understanding one must look up this term in Methodology. Chapter about scenarios in the thesis is quite short – this topic deserves to be developed a little bit more to the depth. The conclusion seems a bit rushed by summarizing only the last chapter of the thesis, not the thesis as whole.

## Verbal assessment:

Sources used in this thesis are relevant by quality as well as quantity. I appreciate the fact that many of the sources are current (from 2018 or 2019). While citing whole paragraphs I would suggest using citation at the beginning of the paragraph (e.g. Author (2020) argues that...). One of the sources (Energy.gov, p. 28) is lacking year of publishing. In the chapter 3.1 Technology (p. 35, 2<sup>nd</sup> and 3<sup>rd</sup> paragraph) and in the chapter 3. 4. Experience (p. 40, 1<sup>st</sup> paragraph) there are citations missing in mentioned paragraphs.

### Verbal assessment:

There are some overtypes in the text e.g. p. 51, 2<sup>nd</sup> paragraph: ...*that goes into landfill to almost zero, Clothing is collected*... or p. 52, 2<sup>nd</sup> paragraph: ...*Steady MIx is*... Otherwise the thesis is well written, easily readable while including clear and relevant arguments. Formal requirements of the thesis are kept.

### TOPICS FOR DISCUSSION DURING THE THESIS DEFENCE

In author's opinion, can the fashion industry be changed on individual level by persuading customers to switch to local and fairly made clothing from natural materials or is it necessary to make changes on global level in the industry by enforcing environmental policies? In chapter 2.1 Microplastics and Laundering, author mentions that both natural and artificial fibres are released by washing into to the water. Do natural fibres such as wool or cotton have negative impact on the environment or do they decompose without harming environment or living organisms? In what way can the natural fibres be harmful? Can the author explain how did she choose relevant trends in each scenario? Why are mentioned trends relevant in presented scenarios?
