Content

The thesis of Radvilé Bankauskaité deals with the migration of highly educated woman from central Europe whose countries have integrated EU in the years 2000. The thesis focuses specifically on gender inequality, expected income and existing migrant networks in destination countries as key determinants of migration. The thesis makes a large and good review of the existing literature.

Women highly educated women migrate first, because income is better in the destination country, second because gender inequality is lower. The author explain carefully the difficulties to build the dataset used in the thesis. The author uses advanced econometric methods.

The main ojective of the thesis is clearly stated. The quality of the economic analysis is very good as well as the use of the empirical/econometric methods (Poisson). The various concepts/variables used are clearly defined. Overall, the reader can easily follow the author's reasonning and understand the author's message. Mrs Bankauskaité also conducts a number of robustness checks that strengthen the main result of the paper. All these elements make the thesis a high quality research work.
