Verbal assessment:

Master Thesis is, according to the title, focused on activating Waqf and Zakat in tackling poverty and supporting investment in Palestine. Although the key objective and research questions are clearly specified within the introduction, the author did not fully cover the whole topic. I would prefer higher concentration on the endowments and its 'task in Palestine, rather than wide and long theoretical introduction. On the other hand, this sweeping theoretical part is necessary for readers without any knowledge on this topic.

The thesis has a logic structure, it contents all the fundamental parts but the quality of several section is a bit low (abstract, clinclusion and recommendation).

Verbal assessment:

The author used a sufficient amount of sources written in English and Arabic. Verses from the Quran were used precisely and they complete the discussed topic.

The bibliographic references seems to be good except some cases. The citation should not be used with the titles (on the page 19 the author used "Dr Rakesh Kumar Singh (2011: 294); the year of publishing should be always presented (page 40, according to Benzouai). In some cases the author forgot to quote at all (i.e. on the page 40). The reference to "United States, 1980" (page 38) is just weird.

Also large using of italics is disturbing. The thesis consists only two tables but there is no list of table that would make searching for them easier.
