Linguistic level of the thesis (style, orthography)	A (excelentní) Given the fact that the author is not a native speaker of the Dutch language with a Slovak/Czech linguistic background, the thesis gives proof of an excellent command of the Dutch language already on C1/2 level in CEFR terms, though the thesis contains - next to several typo's - in its final submitted form still some small syntactic errors or minor cases of wrong word order, wrong use of Dutch articles use of words in a wrong or uncommon semantic/pragmatic way as well as words from a wrong lexicographic-pragmatic register.

Als tweede hypothese stel je: dat de organische gebouwen in Nederland een heel andere vorm zullen hebben dan in Tsjechië, omdat het landschap, de natuur en de cultuur in beide landen verschillend zijn. Maar in hoeverre zijn deze factoren relevant gelet op de belangrijkste voordenkers die je noemt: Gaudí (een Catalaan), Wright (een Amerikaan) en Steiner (een Duitse Oostenrijker geboren in Kroatië)? Met name in het geval van de laatste en de door hem ontwikkelde antroposofie zijn er toch bepaalde antroposofische "regels", die ook in Nederland bouwwerken in zijn trant een eigen, "onhollands" karakter geven?!</p> <p>2. Over kubisme spreek je niet. Maar is in Tsjechië - naast de voorgeschiedenis die je beschrijft - niet ook het Tsjechische kubisme in de bouwkunst een oriëntatie geweest voor "organisch bouwen", zoals in Duitsland dezelfde architectuur die daar dan "expressionistisch" genoemd wordt (m. n. het glaspaleis van Bruno Taut en Paul Scheerbart dat ook in Steiners Goetheanum lijkt door te werken)?</p>
