## QUESTIONS FOR THE THESIS DEFENSE AND OTHER REMARKS

- 1. In your thesis, you present a detailed of the way motherhood is reflected by Franca Treur in her novels. However, you do not say anything about the titles of the novels. To what extent is the reflection on motherhood in the novels reflected in the titles?
- 2. You use the taxonomy developed by Jos Weusten in your analysis of Treur's novels, pointing at the apparent proximity of issues concerning motherhood dealt with by Treur and major strands in literature on motherhood pointed out by Weusten. As you indicate in your thesis, the taxonomy by Weusten is much wider and distinguishes other possible features. Which of these features are remarkably absent in Treur's novels?
- 3. Do you see a fundamental difference in the conceptions of motherhood, as they seem to be the (personal, subjective) basis or framework in the dissertation *De idylle voorbij. Verbeelding van moederschap in Nederlandse literatuur, 1980 tot 2010* by Jos Weusten, who seems to represent a rather critical-negative stand, and the approach of Martina Vitáčková in her article 'Schrijven als vrouw', in which at least according to your summary of the article, Vitáčková seems to represent a rather idealized view on motherhood?
